
RIGHT TO INFORMATION ACT-2005

Section 4:- Obligations of Public Authorities:

1. The particulars of its organization, functions and duties:

Maharashtra state Ecotourism Development Board has been established in 2015 vide G.R. dated 8th Dec. 2015 with an objective of Nature conservation; Nature education; providing opportunities of employment to local community through ecotourism activities.



Functions and Duties:

i) To work as Nodle agency for implementation of Eco-Tourism policy in Maharashtra State.

- ii) To submit with the Government the proposal for making policy, laws and procedure regarding Eco-Tourism.
- iii) To give encouragement to the symbiotic relations among all partners for giving impetus to the Eco-Tourism.
- iv) Capacity building of the partners.
- v) To take measures regarding standardization / Controlling / Impact assessment and Regulation of ecotourism activities for better utilization of available resources for conservation of nature, nature education and for upliftment of the Standard of living of the local residents.
- vi) Selection of Eco-Tourism Sites and development of facilities and make its categorization as per the current standards.
- vii) To arrange programmes with the aegis of Maharashtra State Tourism Development Corporation, Information and Public Relation Department for Publication/propaganda of the information.
- viii) To organize Seminars, conferences and exhibitions related to Eco-Tourism and to participate in such programmes organized by other agencies.
- ix) To obtain membership of International organizations for participating in the programmes related with Eco-Tourism being organized on International level.
- x) To give impetus to the Eco-Tourism with an intention to benefit local community.
- xi) To make appropriate arrangement for providing information to the tourists so that they should not violate the Indian Forest Act, 1927, Forest Conservation Act, 1980, Wildlife (Protection) Act, 1972, Bio diversity Act, 2002, Environment (protection) Act, 1986 and other existing Acts and Rules and guidelines while giving impetus to the Eco-Tourism.

2. Powers and Duties of Officers:

Duties and Powers of Managing Director:-

- 1. The Managing Director shall carry on the powers authorized by the Governing Body and Executive Committee.
- 2. The Managing Director shall be an authority competent to fix the pay and other allowances of the officers / employees of Board as per terms and conditions of their services and to disburse it.
- 3. The procedure followed in the decision making process, including channels of supervision and accountability:

As per the existing Government Rules and delegation of Powers and Bye laws of the Board.

4. The norms set by it for the discharge of its functions:

As per the existing Government Rules and delegation of Powers and Bye laws of the Board.

5. The rules, regulations, instructions, manuals and records, held by it or under its control or used by its employees for discharging its functions:

Establishment of the Board; Bye Laws of the Board / G.R.s / Guidelines & Instructions of Central / State Governments and Board in respect of Ecotourism.

State Government Rules, G.R.s in respect of Administrative and Financial Powers.

Delegation of Powers.

6. A statement of the categories of documents that are held by it or under its control:

Ecotourism Project Reports approved by the Executive Committee of the Board, Proposals for Funds; Records of Distribution of Funds and Expenditure. Executive Committee Meetings and Minutes of meetings etc.

Administrative / Establishment related files. Government Acts / Rules / Guidelines in relation to Ecotourism.

7. The particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof:

Public is free to consult or make representation in relation to frame policy or implementation thereof.

8. A statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public:

Ecotourism Development Board is governed by the Byelaws duly approved by the state government. As provided in the Bye laws, representatives of non government organizations related to Ecotourism activities are appointed as members of the Governing Body and Executive Committee of the Board.

Minutes of the meetings are accessible for public.
